

Employment by sector of economy (%), 2012 Brest region







The official unemployment level in 2012 in the region is 0.9% of the economically active population, which exceeds the national index by 0.4%. The average monthly salary in the region amounts to 87% of the relevant index in the country.



Out of the total workforce of Brest Region, over 24% has higher education, 44% has either a vocational or specialised secondary education.

2. Region's economy

The principal sectors of the region's economy are light industry, food industry, electrical power engineering, machinery construction, production of construction stone. The region specialises in production of incandescent electric lamps, compression-type machines, single-bucket mechanical self-propelled excavators, cookers, chip boards, cotton fabric. Large industrial centres are Brest, Baranovichi, Pinsk, Kobrin, Beryoza.

The agriculture specialises in production of meat and milk, cultivation of potatoes, grain, sugar beet, and vegetables.

Investment potential of Brest region

90% of the total volume of industrial production is provided by the processing industries (production of food products, machines and equipment, nonmetallic mineral products, electric equipment, electronic and optical equipment, chemical production, textile and sewing industries, woodprocessing and production of wood products).

With its volume of the gross regional product Brest Region occupies the 5th place after the city of Minsk, Gomel, and Minsk Region.

3. Foreign trade

Around 80 per cent of the land export of the CIS countries to the Western Europe crosses Brest Region. This determines high development of goods services exports in the region.

Trade companies of the region provide for a sixth of the country's trade. The region's geographical location ensures favourable conditions for international trade.

Companies of Brest Region develop trade and economic cooperation with over 100 countries of the world. 700 companies of all types of ownership and entrepreneurs perform export and import operations.

In Brest Region a positive foreign-trade balance is ensured. The principal foreign-trade partners of Brest Region are Russia, Germany, Poland, Ukraine, Italy, Lithuania, France, the Netherlands, Belgium, the USA.

4. Foreign investment

The priority areas of investment attraction to the region are •high-technology and innovation projects: •high-technology and innovation projects; export-oriented and import-substituting production;
production and processing of agricultural products;
development of roadside service infrastructure;
development of tourist services (along the principal transportation corridors, in the towns with valuable historical and cultural heritage, Belovezhskaya Pushcha National Park).

In Brest Region over 500 companies with foreign investment have been registered. First three places in the number of joint and foreign companies are shared by Poland, Germany, and Russia.

The overall number of companies registered on the territory of Brest Free Economic Zone is 88 as of January 1^{st} , 2013, 62 of them have foreign capital.

Examples of successful operation of companies with foreign investment in the region are

• JV Santa Bremor (sea products processing);

• PC Gefest –Technika (production of gas-, electric stoves and cookers, kitchen air cleaners and ventilation pipes);

• FE Inco-Food (meat processing);

• STiM Ltd. (equipment and machines, paints for road marking);

- CJSC Involux (furniture production);
- Vegas LLC. (orthopedic mattresses manufacture);
- and many others.

Since May 1998 Brest Region has been a member of the transborder Bug Euroregion which includes Lublin Province of Poland and Volyn Region of Ukraine as well.

5. Transport and communications

• The length of general motorways is 10.7 thousand km.

• The length of operating tracks of general purpose railway transport is 1062 km.

• Brest railway junction is one of the largest ones in Central Europe and it completely ensures transit of Western European countries to the CIS countries in Moscow and St. Petersburg directions. Large railway junctions are located in Brest, Baranovichi, Luninets, and Zhabinka.

• The international transportation corridor Berlin-Warsaw-Brest-Minsk-Moscow and a direct way to Vilnius and Kyiv cross Brest Region.

• Druzhba oil pipeline and Torzhok-Minsk-Ivatsevichi and Kobrin-Brest-Warsaw cross the region.

• Brest airport of class IV (located 17 km to the East from Brest) has the status of an international one; at present Gomelavia airline operates regular flights from Brest airport.

• The distance from Brest to Minsk is 345 km.

6. Education and science

In Brest Region there are 4 state higher educational institutions, 29 research, design, and survey institutions and organisations. The research potential of the region is mostly oriented towards applied research. Higher educational institutions engage in research in the field of biology, sewage treatment, development of new types of construction materials.

The following organisations function in Brest Region:

• technical park of Centre of Technological Development Introduction BRMUC;

• research and technological park of Brest Innovation Business Centre LLC.




R&D organizations by region and Minsk City, 2012


